





2020: Tutorial for Online Proposals

What are the steps for submitting a proposal to the Water Research Foundation?

1. Read the RFP for the particular project. Take note of the deadline date and time.
2. Read the Guidelines For Research Priority Area Program Proposals
These are the instructions for preparing the proposal and explain how to be in compliance with the proposal submission requirements and the terms and conditions of the Project Funding Agreement. It's very important that prospective researchers, and their grant, finance and contract administration staff, review and understand the Guidelines before investing the time to prepare and submit a proposal.
3. Read the Sample PFA (Project Funding Agreement)
Reading the above will ensure you are able to comply with our requirements before you put the time into creating a proposal.
4. Ensure you have a login to access the required documents to upload your proposal.
If you have worked on a project before with WRF, you probably have a login. Use the "Forgot Password" page to identify if you have a login. Allow 2 business days if you are requesting a new login.
5. Login at <https://proposals.waterrf.org/Pages/RFPs.aspx> > Select the desired project for your proposal > download and save the compressed Proposal Component Packet folder.
6. Extract the files from the compressed Proposal Component Packet folder.
7. Complete your information for each document of the proposal.
The documents in the Proposal Component Packet are either Word templates or Word forms. As you complete and save each document, you may want to append the rfp number to the beginning of your file name. Underscores are allowed in file names but dots (.) are not, except preceding the file extension (.pdf).

Scan or convert your files to PDF file format. ***** TO SUBMIT YOUR PROPOSAL, YOU WILL ORGANIZE YOUR PROPOSAL INTO TWO PDF FILES CONSISTING OF YOUR**

TECHNICAL REVIEW DOCUMENTS AND YOUR FINANCIAL REVIEW DOCUMENTS.
REFER TO THE PROPOSAL GUIDELINES.

IT IS IMPORTANT THAT THE DOCUMENTS YOU UPLOAD ARE:

- IN PDF FORMAT
- FILE NAMES DO NOT CONTAIN NON-STANDARD CHARACTERS (E.G. / \ ? % &)
- PDF FILES ARE NOT LOCKED WITH PASSWORDS OR SECURITY SETTINGS

Ensure you have uploaded all required documents and clicked the Submit button before the RFP date and time deadline. It is recommended you keep a local copy of the documents you are submitting.

8. If you are a non-U.S entity, the W9 and Certification and Assurance forms do not apply. Simply convert to PDF without completing the information and include with your submission.
